Buchanan County Sheriff's Department logged about 40 hours during July. Deputy Tyler Klenzman reported calls for service were disorderly conduct, investigations, and warrant checks.

Dan Walter, member of the Buchanan County EMS Association, presented information on the EMS Essential Service Levy that will be on the November 2024 ballot. The essential service levy of 75 cents per \$1,000 for 15 years should generate enough funding to make EMS in the county sustainable, reliable, and provide needed resources.

Lisa Kremer of Buchanan County Economic Development Commission (BCEDC) presented an update on what they have been up to in 2024. Tourism is an integral part of economic development so they continue to partnership with the Buchanan County Tourism Bureau. The Housing Needs Assessment is now available on their website. BCEDC & Hawkeye Community College continue to develop the Lunch & Learn and Leadership Programs. The new Laborshed study is underway and should be completed in October. Childcare continues to be a big focus for our communities.

Fire Chief Crow reported the department had 2 control burn requests, 1 storm watch, and 6 medical calls since last meeting. Broken passenger window has been replaced on the truck and Derrick Beck has moved out of the area so resigned from the department.

No BCEDC meeting in July. Mayor Cook reported nuisance abatements are moving along slowly but property owners are cooperating and plans to have them cleaned up by November 1st. The DOT is working with property owner on Washburn Avenue for removal of the storage container. He reminded Council about ideas for the railroad property.

Public Works Director reported Quality Flow was here to do annual lift station check and need to replace pump that is not working.

Motion by Lamphier, second by Lincoln to approve the first reading of Ordinance #113 Amending Chapter 155 – Restricted Residence District. Ayes: Adams, Slack, Lincoln, & Lamphier. First reading was approved.

Motion by Lamphier, second by Slack to not participate in Maquoketa River Watershed Management Authority FY25 Financial Commitment at this time. All ayes; motion carried.

Motion by Lamphier, second by Slack to adjourn. All ayes, motion carried. Meeting adjourned at 8:08 p.m.
