Deputy Tyler Klenzman reported the Buchanan County Sheriff's Department logged 48 hours during November with calls for service being 911 hangups, verbal argument, and assist other agencies.

Public Works Director reported pump was installed at lift station so back up to full capacity and bridge inspection was complete with a few maintenance comments.

Fire Chief Crow reported the fire department had been on 4 medical and 2 rollovers since the last meeting. He attended the 911 EMA meeting where it was noted that all radios should be switched over by end of December and the generators for the towers around the county are failing so EMA will be looking to repair or replace. Mayor Cook reported when he contacted Windstream regarding slow internet service within Lamont, their reply was each customer is different with regard to billing and speed so they would need to call in individually. He will continue to work with them for better internet service. Mayor Cook attended court on the 315 Church Street property and City will be the owner after sixty days so clean up can begin. He has issued a nuisance abatement order at 619 Bush Street property.

Motion by Devlin, second by Lincoln, to certify delinquent city service bills to property taxes for collection. All ayes, motion carried as Resolution 24-28.

Mayor Cook presented property pictures and assessor report of 305 Church Street property. Motion by Lincoln, second by Slack to authorize abandonment proceedings pursuant to Iowa Code Section 657A.10B against real property located at 305 Church Street. All ayes; motion carried as Resolution 24-29.

Discussion was held on incentives to attract new businesses to Lamont. There are several programs available through BCEDC and INRCOG. Considerations for FY26 budget were discussed.
