Buchanan County Sheriff's Department logged 19 hours of service in February. Deputy Tyler Klenzman reported two hours for calls for service and rest for patrol. Since weather is warming up, he wants to remind residents to be vigilant, keep doors, windows and vehicles locked and if you see something, report it.

Randy Kramer from Prairie Road Builders presented pricing proposal for 2025 road work. Prices remained the same from 2024 with Seal Coat over 15,000 \$2.90/sy, 6000-15000 \$3.00/sy, under 6000 \$3.18//sy. Surface Patching went up \$10/ton to \$305.00/ton for Cold Mix. Motion by Slack, second by Lamphier to accept pricing proposal. All ayes; motion carried as Resolution 25-04.

There was a request to allow chickens on property at 935 Jackson Street. Code of Ordinances, Chapter 55 Animal Protection and Control, 55.05 states "It is unlawful for a person to keep livestock within the City except by written consent of the Council. Motion by Lamphier, second by Slack to send written consent to property owner that chickens shall be penned or fenced no closer than

20' to residences other than the residence on the premises, no more than 6 chickens are permitted on the premise, and waste disposal plan is in place. All ayes; motion carried.

There was also a request to allow Nigerian dwarf goats on property at 125 South Street. Motion by Slack, second by Devlin to send written consent to property owner that goats shall be penned or fenced no closer than 20' to residences other than the residence on the premises, no more than 2 goats are permitted on the premise, and waste disposal plan is in place. All ayes; motion carried.

City Clerk reported Fire Department had been on 1 controlled burn request, 2 fire, 2 mutual aid, and 2 medical calls since last meeting. Fireman Lamphier attended the EMS meeting where discussion was on radio upgrade that will probably cost \$5,000 per radio per fireman on the department. No BCEDC report.

Mayor Cook reported lowa DOT was looking at speed zone changes to 40 or 45 mph on Highway 187 city limits and installing a jake brake sign if City Council has an ordinance with how it's going to be enforced. He's working with City Attorney on second Church Street property. Spring Clean-up is April 5th with Schafer bringing dumpsters for appliances and metal. He presented an informational letter to send to new homeowners.

Public Works Director reported City was on rural water while repairing chlorinator.

Motion by Lincoln, second by Slack to approve Resolution 25-05 certifying delinquent city service bills to the property taxes for collection. All ayes; motion carried.

Motion by Lamphier, second by Slack to approve health insurance reimbursement to City Clerk. Ayes: Adams, Devlin, Lincoln, Slack, & Lamphier. Motion carried as Resolution 25-06.

Motion by Devlin, second by Adams to approve maintenance agreement for Kyocera printer. Ayes: Slack, Lincoln, Lamphier, Adams, & Devlin. Motion carried as Resolution 25-07.

Motion by Slack, second by Lamphier to approve April council meetings to accommodate the budget submission process for FY26. The Proposed Property Tax Hearing will be April 2nd at 6:00 pm with only item on agenda followed by a second meeting at 6:15 pm to set budget adoption hearing and any normal meeting agenda items. No meeting on normal meeting night of April 9th. Budget Adoption Hearing will be held on April 23rd at 6:00 pm along with any normal meeting agenda items. All ayes, motion carried.

Motion by Slack, second by Lincoln to adjourn. All ayes; motion carried. Meeting adjourned at 7:51 pm
